### Notice of no objection

A notice of no objection is required for filming/photography in the Royal borough of Kensington and Chelsea if your cast and crew is larger than 5 persons and/or any of your equipment is not handheld.

### Parking

The Royal Borough of Kensington and Chelsea can suspend parking for technical vehicles if required. Suspensions must be submitted with a completed suspension form (ask for within) along with an annotated map. Residential suspensions must be replaced with alternative parking. Occasionally suspensions can be put through outside of these deadlines, however, this will incur an £80 late application fee.

Please note that the below prices refer to suspensions lasting 1-5 days. Please enquire further for longer suspensions.

### Highways

A Temporary Highway Consent (THC) Licence is required to place any structure on the highway, e.g. dolly and track, lighting etc. Please complete THC form (ask for within), attach annotated map and send to film office.

If you want to use any mechanical lifting equipment on the highway, a Mobile Lifting Operations (MLO) Licence is required. For more information, please visit [website](#).
