In order to standardize, simplify and reduce confusion over the payment to the Atlanta Fire Rescue Department & Inspectors personnel, the payment for an employee's services shall be conducted as set forth:

1. The pay rate for a "fire watch" shall be set at \$140.00
Please note: Any event over 4 hours shall be charged a fee of 35.00 dollars per hours.
2. Payment shall be made by the hiring individual directly to the Fire Inspector;
3. Payment shall be made immediately after the completion of a work cycle or immediately after the termination of the need of a "fire watch," or as may be mutually agreed to by the both parties.
