Crofton Heath Estate Filming

The Crofton Heath Estate area has a very high volume of location filming.

To ensure filming remains tolerable and sustainable for local residents the following guidelines for filming and parking should be followed.

Due to the very high level of filming the area receives, we are only able to support one large scale filming per bubble, per months.

- Red Area Poplar Avenue, Rose Dale, Wisteria Close & Lime Close
- Blue Area Fairbank Avenue, Jasmine Close
- Yellow Area Drayton Avenue & Morley Close
- Green Area Lansdowne Avenue, Bramley Close, Wyndham Close & Ormonde Avenue

A general request – all companies when undertaking filming on the estate are requested to show consideration to local residents who maybe affected by filming, to minimize disruption wherever possible and be mindful of residents needs for quiet enjoyment. Please inform the film office, contact details below, of which number property you will be filming at.

Terms & Conditions

Large Scale productions (more than 10 crew) will need to consult local residents in this area at least one week before your shoot day

For filming anywhere in the Crofton Heath Area - Conduct a letter drop with a filming and parking proposal to all residents on the Crofton Heath Estate (giving a least 5 working days). Due to the fact that the estate is a cul de sac, we ask that ALL residents on adjacent roads are letter dropped, not just the houses near to your film location. See letter – drop zone map on last page.



No vehicle movement to be before 08:00 or after 21:00



All rubbish must be cleared away upon completing filming. Please provide your rubbish collection company details to the film officer handling your request.

Only essential technical vehicles (usually 5 or less) will be given clearance for parking on the estate. Please provide a detailed parking plan of where you wish to park prior to filming.



We ask production companies to make arrangements with the immediate residents to use their driveways in order to minimize the impact of vehicles on the street.

Unit facility vehicles and private cars will not be permitted to park in the immediate area, advice on unit base parking which service Crofton Heath is given below. Please do not park vehicles opposite each other or resident's vehicles as the roads here are too narrow to accommodate restricted access for traffic flow.

Donations - Film companies working in Crofton usually give a donation to the Crofton Residents Association. Bromley Film Office collect the donations on behalf of the Residents Association via invoice. Donations must be paid prior to the filming date. In the past some film companies who agreed to make a donation did not do so after filming so the donation is now requested to be made prior to filming.

Temporary Traffic Restrictions (TTR) - All control of traffic or pedestrians now requires written permission from Bromley Council Highways department, please contact the Bromley Film Office to discuss your requirements

Noise Levels during filming - As this is a residential area we ask that all noise is kept to a minimum for the duration of the film shoot. Any filming before 8am or after 9pm will have to involve a consultation with all residents of the estate
